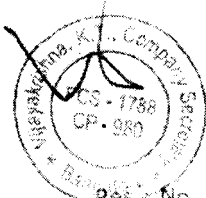
Dear Sir,

I, Vijayakrishna K T , Company Secretary in Whole-Time Practice (FCS No 1788, CP No 980), having office at # 496/4, 2nd Floor, 10th Cross, Near Bashyam Circle, Sadashivanagar, Bengaluru – 560 080, duly appointed as Scrutinizer by Encore Software Limited for the purpose of scrutinizing the voting through Ballot Paper at the 27th Annual General Meeting of the Company, pursuant to Section 109 of the Companies Act, 2013, read with Rule 21 of the Companies (Management & Administration) Rules, 2014 as amended from time to time and the provisions of Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The Management of the Company is responsible to ensure compliance of the requirements of the Companies Act, 2013 and Rules relating to voting through Ballot Paper at the Annual General Meeting venue for the resolutions proposed in the Notice of the 27th Annual General Meeting of the Members of the Company held on 30th September, 2019. My responsibility as the Scrutinizer is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to make the Scrutinizer's Report for the votes casts in "favour" or "against" on the resolutions proposed in the Notice convening the 27th Annual General Meeting of the Company.

Since the Company has not provided e-voting facility, this report is given only for the physical voting taken place at the Annual General Meeting through Ballot Papers.

The Members holding Equity Shares as on the "cut-off date" were entitled to vote on the resolutions proposed in the Notice calling the 27th Annual General Meeting.



The Ballot register was prepared to record Equity Shareholders' Assent or Dissent, received mentioning the particulars of name, address, folio number or client id of the shareholders, number of share held by them, nominal value of such shares, whether the shares have differential voting rights, if any, details of ballot forms which are invalid.

The Ballot Papers received were scrutinized and reconciled with the records maintained by the Registrar and Share Transfer Agent (RTA), Integrated Registry Management Services Private Limited. Six Ballot Papers have been rejected and treated as invalid due to mismatch/incomplete details.

The details containing *inter alia*, the list of the members, who voted "for" or "against" on each of the Resolution that were put to vote, were derived from the Ballot Papers as received.
